What, if any, advantages do you see for children in terms of the proposed changes?	<ul style="list-style-type: none"> • More learning time will have a huge impact on students • Reduce disruption to teaching and learning - • Longer form time will help with the administrative tasks of being a form tutor and providing pastoral care
What, if any, disadvantages do you see for children in terms of the proposed changes?	<ul style="list-style-type: none"> • There has been a change to the internal structure of the initial proposal, this now has five, one-hour lessons. • The school site will be open and supervised from 8am to enable pupils to arrive promptly for the school day to start at 8.40am. • The start and end time for all staff has been calculated providing time for meetings/ briefings. The school site opening and closing times will also be re-communicated with all staff.
Do you have any comments/ queries that you would like us to consider?	<ul style="list-style-type: none"> • The school site will open from 8am for breakfast club and not 8.30am as stated in the initial proposal. • A priority for the school is providing a high-quality curriculum offer, to support this there is an extracurricular timetable available for all pupils as well as calendared trips and events throughout the year to support personal development.

What, if any, advantages do you see for children in terms of the proposed changes	<ul style="list-style-type: none"> • More time given to lunch time • Removal of split lessons in Year 7 • More learning time and increased form time • Time management in the morning as it will be focused and organised • More time in certain subjects to aid understanding (period 2 in initial proposal)
What, if any, disadvantages do you see for children in terms of the proposed changes?	<ul style="list-style-type: none"> • The bus company has been made aware of the changes for September 2024 to best support pupil arrival and collection. The bus stop outside of the school gates will continue to be supervised by a staff member before and after school. • We will aim to support pupils whom will be impacted due to travel changes being required or for our pupils that collect sibling/s from local primary school- please contact the school directly to discuss further. • There has been an extension of break time to twenty minutes for all year groups at 11.10am. The lunch time for both Key Stages has been brought forward by 5 minutes from the initial proposal. • Pastoral care is available to all pupils through their form tutor, head of year and teaching staff to support with organisation, time management and wellbeing. This will be prioritised in September 2024 within period 1 lessons and end of the day sessions with form tutors. • The school site will open at 8am; the extracurricular timetable will continue starting from 3.15pm from September 2024. • Research and communication with local school's/ Trust secondary school has taken place to best support the proposed structure of the school day. The wellbeing of staff and pupils has been strongly considered with the decision made to start earlier and finish slightly later than current structure to allow for extra curricular

	<p>clubs to continue to be provided as well as enable a reasonable finish time for staff members after meetings and training sessions that will commence 3.20pm (these differ in length over the course of the academic year).</p> <ul style="list-style-type: none"> All pupils have a form tutor whom they will see for a longer period of time each day. Form Tutors will support with areas of pastoral care, building strong relationships and lines of communication with parents and carers. The school has a Safeguarding Team whom all pupils can contact as well as Mental Health Lead and School Nurse. Our PSHE curriculum provides information linked to Mental Health and how this can be supported inside and outside of school.
Do you have any comments/ queries that you would like us to consider?	<ul style="list-style-type: none"> There has been a change to the initial proposal of break time as there will now be one break time for 20 minutes for all pupils to prioritise learning and minimise disruption to lessons. Pupils will be in 'zones' during breaktime within their year groups around the school site with additional access to toilet facilities and additional staff members on duty points. There will be changes made to the Canteen/Food Pod in terms of layout and opening times to facilitate all pupils having access to food and drinks. The timetable for period 1 will be published on the school website and will consists of: PSHE/ RSE, Assembly, Formation, Literacy/ Numeracy and Know Your 3 (attendance, behaviour and reward focus). There will be updates to the staff duty rota to best support break and lunch queues with additional staff deployed at key areas.

Pupils will be able to purchase food from here at both break and lunch time. There will be changes made to the Canteen in terms of layout and ways of accessing food and drinks.
Do you have any comments/ queries that you would like us to consider?	<ul style="list-style-type: none"> There will be a 20-minute break at 11.10am and a split lunch time for the Key Stages starting from 12.30pm until 2pm. Pupils currently have 30 minutes for lunch and this will remain for September 2024. As a result of changing the internal structure of the day, our leadership and office teams will be better positioned to utilise school staff during the school day. Changes have been made to the setting and marking of homework. The information has been published on the school website and can be found in the Teaching and Learning Policy- this was published in January 2024.
